

t the convention in 2009, the late General President Finley announced the formation of a scholarship fund to provide education assistance for members' dependents. It was the early days of the Great Recession. His vision is now in full swing. Since the first scholarship of \$5,000.00 was awarded in 2010, we have been able to award one hundred and six scholarships in total.

In 2017, then-General President Stepano began a golf tournament to raise funding for the scholarship fund. As we were preparing for the Golf tournament in 2022, Vice President Rob Mason passed away after nearly a two-year battle with cancer. Knowing his love of the game, just prior to his passing, we renamed the event to The Rob Mason Golf Classic to benefit the Patrick D. Finley Scholarship Fund. The tears welled up in Rob's eyes as we delivered the news shortly before his passing. These two men were giants in this organization and organized labor. The Scholarship fund will always be a testament to them. Through their actions, financial relief is being provided to the membership through tuition assistance.

As I have mentioned in the past, we will hold an apprentice competition in January 2026 at the World of Concrete in Las Vegas. The planning is underway, and Executive Vice President Lair along with the Director of Health, Safety and Training Longbrake are smoothing out the details. The cost is significant, but we still strive to make this an annual event. It is important to showcase our skills and the training the OPCMIA provides to the future workforce in the age-old art of Concrete Finishing and Plastering. So much technology has changed, and we are staying at the forefront of this industry.

This brings me to 3D printing of concrete. Local 528 is setting the bar for this emerging industry. They are working with the leaders in this fledging industry and are printing housing in Alaska as we speak. This technology is here and will change the industry, just like drywall did in the 1950s. We must welcome it and move with it. Chief of Staff Santos and I are meeting with 3D printing contractors, with some success. I see a windfall of work, especially for Plasterers applying interior and exterior finishes. Stay Tuned!

In 1980, a young Richard Bailey (emphasis on young in past tense), joined local 109 in Akron, Ohio. In 2000, Richard was hired on staff as an Organizer for the OPCMIA by General President Dougherty. Richard has dedicated his life to expanding the membership of the OPCMIA. He has worked tirelessly at all tasks he has been assigned by the General Presidents he has served under. In 2022, when General President Stepano announced his retirement and the General Executive Board confirmed me to replace Dan, I appointed VP GEB member Bailey to the office of General Secretary Treasurer. Again, Richard rose to the challenge. I still fondly recall when I met Richard in 2005. He

The Front Line

ince taking office, President Trump and his administration have attacked federal employees and their unions. The principal attack came in the form of Executive Order No. 14,251, Exclusions from Labor-Management Programs.

President Trump issued this Executive Order on March 27, 2025; and, with a stroke of a pen, he took away the rights to organize and bargain collectively from nearly two-thirds of all federal employees. President Trump carried out this attack because he believes that federal employee unions "have declared war" on his agenda.

Through the Executive Order, President Trump invoked the

provisions of two statutes - the Federal Service Labor-Management Relations Statute and the Foreign Service Labor-Management Relations Statute - that enable a President to exclude subdivisions of agencies or agencies where (1) they have as their primary function intelligence, counterintelligence, investigative or national security work and (2) the provisions of the Statute cannot be applied in a manner that is consistent with national security considerations. In the past, Presidents have utilized these provisions to exclude subdivisions like the Naval Special Warfare Development Group or the National Drug Intelligence Center. By contrast, President Trump invoked these provisions to exclude entire departments, like the Department of Defense, the Department of State, and the Department of Veterans Affairs. In so doing, the President explained that he would not allow unions to obstruct his agenda, but that he would work with him. In fact, employees who were unaffected by the Executive Order include the border and customs employees and police employees, whose unions endorsed Trump during the 2024 election cycle.


Federal employee unions have defended themselves against the Executive Order by bringing lawsuits in federal courts. There are four such lawsuits pending in



the court system (which are only a small fraction of the more than 270 lawsuits currently pending against the Trump administration). Generally, the federal employee unions have been successful in obtaining injunctions from district courts. Such injunctions would prevent the implementation or enforcement of Executive Order No. 14,251. However, the Trump administration has filed motions

for stays of those injunctions. These motions basically seek to prevent the injunctions from going into effect. To date, the administration has been successful in obtaining two such injunctions in one court: the United States Court of Appeals for the District of Columbia Circuit, where judges appointed by President Trump during his last administration have gone out of their way to grant stays of the injunctions, even to the point of ignoring the court's own case law, giving the Trump administration a pass at proving its case, or doing the work for the administration. In so doing, the court has green-lighted the Trump administration's attack upon federal employee unions and, by extension, the federal employees themselves.

The federal employee unions are still fighting to defend the right to organize and bargain collectively in the federal sector. However, the odds against their victory are increasing because, as any employee knows, the system is stacked against them. While the OPCMIA may have few members in the federal workforce, every member of the International Association should be supporting their brothers and sisters in the federal sector. Because, once the federal union sector falls, then the administration will come after unions in the private sector.

Job Corps Update

n late May, the U.S. Department of Labor (DOL) announced plans to suspend operations at all contractorrun Job Corps centers by June 30, 2025, citing low graduation rates and an increasing financial burden on taxpayers. According to the department, the publicly funded program has delivered underwhelming results while costs and budget deficits continue to rise.

However, serious concerns have been raised about the data underpinning the DOL's decision. The **Transparency Report**, submitted by the Department of Government Oversight and Evaluation (DOGE) to DOL and Congress, included numerous inaccuracies. For example, the report claimed an overall graduation rate of 37% and an average wage barely above

minimum wage. In contrast, DOL's **own data** shows a graduation rate of **60**% and an average wage of **\$17.00/hour** for Job Corps graduates. Additionally, programs like **NPIJATF** report graduation rates near **60**% and average wages of **\$21.00/hour** for preapprentices.

However, on June 24th, a federal judge issued a preliminary injunction blocking the move, ensuring that the Job Corps program will continue to operate while legal proceedings play out.

The injunction reinforces an earlier temporary restraining order issued by U.S. District Judge Andrew Carter in June, who instructed the Department of Labor to cease all actions related to student removals, staff layoffs, and center closures until Congress explicitly authorizes such changes.

"Once Congress has passed legislation stating that a program like the Job Corps must exist, and set aside funding for that program, the DOL is not free to do as it pleases; it is required to enforce the law as intended by Congress," Judge Carter wrote in his decision.





Background on Job Corps

Established in 1964 as part of President Lyndon B. Johnson's War on Poverty, Job Corps is a federal program designed to support young people ages 16 to 24 who are unemployed and out of school. The program provides tuition-free education, vocational training, housing, meals, and healthcare at residential centers across the country.

There are currently 123 Job Corps centers in the U.S., most of which are operated by private contractors under the oversight of the Department of Labor. These centers collectively serve more than 25,000 students, many of whom come from vulnerable or underserved backgrounds. The job corps has provided services to over 3,000,000 students since its inception.

Fallout from Closure Plans

As the Department of Labor moved forward with preparations to shutter the centers, confusion and distress followed. Many students were forced to leave their campuses without a clear plan for housing or continued education, many reportedly ended up in homeless shelters. Staff at the centers faced sudden job insecurity, and training programs including NPIJATF were abruptly terminated.

The National Job Corps Association (NJCA), a nonprofit composed of business, labor, volunteer, and academic stakeholders, filed a lawsuit to block the suspension, arguing that the closure would displace tens of thousands of youth and lead to widespread layoffs. The NJCA and all stakeholders in the job corps community including the NPIJATF and the OPCMIA will continue to fight to keep the program open.

Next Steps

The court's preliminary injunction keeps Job Corps operating for now, but the legal battle is ongoing.

Do not be surprised If/when legislation to nationalize a "right to work law" comes to the floor of Congress. The President will surely sign it if it comes before him.

So, it looks like we have gone from the most pro-union

administration we have ever had, to the most antiunion administration back-to-back. Unfortunately, most, if not all, the gains we made in the past four years could soon be erased. We will just push back as hard as we can until we make the changes we need in the Congress in two years and then with the presidency in 2028.

Rosella Scott Jr. was born in Bedford, VA, the only son of six who moved to Washington, DC in 1964. In 1964 he joined local 891 as a Cement Mason Apprentice under his brother-in-law, the late Hubert Logan who was a Foreman for Knollman Construction Company in Rockville Pike, Maryland. Under the apprenticeship rules at that time if a company or foreman hired you, you worked on the job completing your training. Brother Scott completed his apprenticeship in 1967.

Upon completing his apprenticeship, Brother Scott, along with the late David Robinson became instructors

of the first Washington, DC Pre-Apprenticeship Program, Project Build at 11 First Street in Northeast, DC. Project Build was a successful program for the union and community. In 1977 Brother Scott became a Business Agent for Local 89, although he soon realized his true passion was training. He resigned as Business Agent of the local and became the Potomac Job Corps Instructor from 1978 to 2006.


DAVID L. ROBINSON
